## LOBBYIST REPORT

**HB 27** 

Connick, Patrick(R) Claitor(R)

Provides assistance and protection from domestic abuse to all persons presently or formerly living in

the same residence as spouses.

Position: Support

Remarks: Importance to the public and administration of justice, consistent with existent law and

currency of issue.

LOBBYIST REPORT: The Bar was instrumental in the passage of this bill as it narrowly passed in the House (getting one more than the needed 53 votes) and failed to pass on its first attempt in the Senate,

though it ultimately passed 25-13.

**HB 74** 

Marcelle, Denise(D)

Provides relative to disposition of children after adjudication of certain felony-grade delinquent acts.

Position: Support

Remarks: This bill extends post-adjudication judicial review to certain juvenile offenders that were previously denied such review. Permits the possibility of parole for juveniles that are currently required to spend their entire sentence in secured custody. Current law does not allow for rehabilitation consideration. Repeals the "Vitter Kids" law. This should result in a substantial cost savings to the State.

> LOBBYIST REPORT: While this bill cleared the House Criminal Justice Committee with amendments, it was never heard on the House floor.

HB 227

Shadoin, Rob(R) Luneau(D)

Provides relative to sealing and delivering depositions.

Position: Opposed

**Remarks:** Provides relative to sealing and delivering depositions. "At the request of the parties," allows the deposition to be sealed and delivered electronically. This is a matter of wide interest and importance to the bar as a whole and the practice of law and has a strong likelihood of passing.

> Not all attorneys have embraced technology and it is not always reliable (which is why electronic service must be consented to in writing).

LOBBYIST REPORT: This bill passed easily.

> LOBBYIST REPORT: This bill was not heard in committee—a related bill re "wage transparency" was defeated.

HB 322

Jenkins, Sam(D)

Provides relative to advising an enrolled attorney

of a court filing.

**Remarks:** Amends CCP 253 to require service of all pleadings filed with the clerk to be served on "all other attorneys of record in advance or no later than three days after the filing of the pleading." The amendment does not provide for service on unrepresented parties and does not specify the method or manner of service. The amendment could be read to allow up to three days to serve a pleading. The amendment provides for discretionary sanctions for failure to comply.

> Service of all pleadings "on the adverse party" is already mandatory under CCP art. 1312 and CCP art. 863 already provides for sanctions if a

certificate of service is signed but service is not made. As amended, CCP 253 would be in conflict with CCP 1312 and could be interpreted as the more recent and specific expression of the will of the legislature and thereby controlling.

LOBBYIST REPORT: After discussions with the author, this bill was withdrawn.

Asbestos and silica bill. This bill has been consistently opposed by the LSBA Legislation Committee as a special law providing special venue rules and limiting the liability of a special class of tortfeasors and limiting access to justice for a subclass of claimants in contravention of HOD policy against certain limitations of liability.
